SELF CONTAINED BREATHING APPARATUS SPECIFICATION

The following specifications are set for Self Contained Breathing Apparatus (SCBA) used by Sol Plaatje Emergency Services.

1) Pre-amble:

- a) Sol Plaatje Emergency Services are responsible to render a fire fighting, rescue, disaster management and humanitarian's service to the residents of the Sol Plaatje Municipality.
- b) The Emergency Services has several standard operational procedures determining the use of a breathing apparatus by any member of the service.
- c) The Emergency Services has standardized on the MSA range of breathing apparatus for the effective use of current sets and the adaptability of any future sets.

2) Breathing apparatus:

a) General Specifications:

- i) The breathing apparatus must be the MSA breathing apparatus consisting of the face mask, back plate, demand valve and cylinder as per specifications set in this document.
- ii) The bidder must prove that they are importers and distributors of the MSA Breathing Apparatus or their appointed agents and that they have the necessary technical personnel to maintain the sets and that they carry the needed spare parts to maintain the breathing apparatus sets.

b) Face mask:

- i) The face Mask must be the Ultra Elite face mask complete with a AUER Demand Valve (DV) complying with the following:
 - (1) The possibility of cross contamination of micro-organisms through the face piece and demand valve must be eliminated. The supplier must supply proof of compliance to this.
 - (2) The face piece must have a polycarbonate lens coated with silicate on both sides.
 - (3) The facemask must have a thermoplastic elastomer nose cap.

- (4) The facemask must have a “plug-in” connector for the demand valve. The other end of the medium pressure line must have a quick connect safety coupling (snap-coupling).
- (5) The demand valve must have a swivel medium pressure line at the connection to the demand valve.
- (6) The demand valve must be positive pressure activated automatically with the first breath.
- (7) The facemask must be complete with a spider harness with quick release buckles and a neck strap.

c) Backplate:

- i) The backplate must consist of the harness system, a pressure reducer complete with a medium pressure line and a high pressure line with a pressure gauge measuring in BAR – between 0 BAR and 350 BAR.
- ii) The pressure gauge must have night visibility, must be water tight and shock protected.
- iii) The pressure reducer shall have a low pressure warning whistle that must activate at 55 BAR and gives a continues whistle while the cylinder is open.
- iv) The backplate must accommodate a 300 BAR 6 liter cylinder with ease without disturbing the normal operations of the fire fighter.
- v) The harness system must be able to be adjusted for comfort and must be manufactured from a flame retardant material. (aramud/nomex). The harness consist of the following:
 - (1) Shoulder wide padded straps, and
 - (2) Wide padded hip straps complete with buckle.
- vi) The wide padded hip straps buckle must have a quick release system for emergencies.
- vii) The backplate must have carry slots for easy handling and transport of the apparatus.

3) Cylinders.

- a) The cylinder must be manufactured in accordance with SABS 019
- b) The Cylinders must be a seamless steel cylinder.
- c) The colour must be Canary yellow (C61) with a French gray (H30) band on the shoulder and neck of the cylinder.
- d) Water capacity – 6 liter.
- e) Working pressure – 300 BAR.
- f) Hydrostatic test pressure – 450 BAR.
- g) Maximum empty weight – 9 kg
- h) Outer measurement sizes: Maximum 550 mm in height and 150 mm wide.
- i) Wall thickness: Side walls – a minimum of 4 mm and bottom wall – a minimum of 6mm.
- j) The cylinder must be able to withstand a minimum of 75 000 filling cycles at 300 BAR without leakages.
- k) The cylinder must be able to withstand at least 12 000 cycles of test pressures during hydrostatic tests at 450 BAR.

l) Cylinder Valve

- i) The valve must be able to withstand 300 BAR pressure.
- ii) The valve must have a test pressure of 350 BAR.
- iii) The torque pressure of the valve must be at least 65 Nm.
- iv) The valve must consist of the following parts: (See sketch attached.)
 - (1) Hand wheel complete with protective rubber cap.
 - (2) Valve gasket kit
 - (3) Protective tube, filter and 300 BAR plug

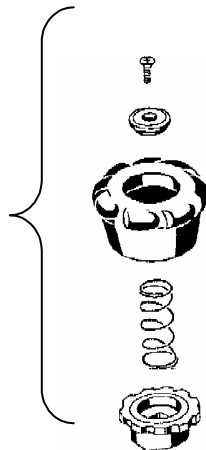

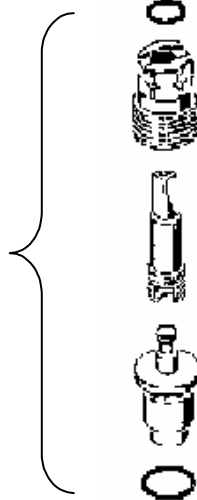

Sketch of valve indicating the three units:

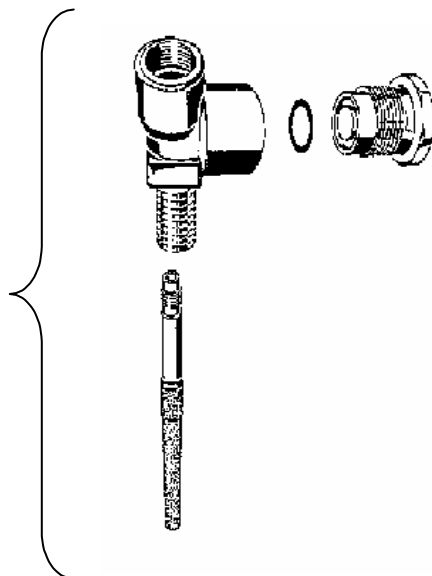

- 2.7.1 In addition to above-mentioned goals, the Regulations [12.(1)] also make provision for organs of State to give particular consideration to procuring locally manufactured products.

ESTABLISHMENT OF HDI EQUITY OWNERSHIP IN AN ENTERPRISE

Equity ownership shall be equated to the percentage of an enterprise which is owned by individuals classified as HDI's, or in the case of a company, the percentage shares that are owned by individuals classified as HDI's, who are actively involved in the management and daily business operations of the enterprise and exercise control over the enterprise, commensurate with their degree of ownership.
