An accredited Training Service Provider / Driving School is required to provide learner licence, and driver licence training to candidates in line with the National Road Traffic Act, No 93 of 1996.

Providers need not be accredited, however, if they are, they are requested to provide proof of the accreditation and provide proof of scope of training. The Motor Registration Section of Sol Plaatje Municipality will be requested to provide verification of the Driving Schools.

The practical training lessons must take place in Kimberley. The Provider must have roadworthy vehicles/bike that can be utilised for the practical training lessons and driver testing. The provider must include 15 hours of practical lessons for motorcycle, code B and code C1. The provider must include 20 hours of practical lessons for the code EC.

A roll-out plan is requested for each item, with timeframes. Lessons may be conducted during working hours (and after working hours) as arranged and agreed with the identified learner and supervisor.

A monthly progress report must be submitted with attendance registers.

On completion of all training the following is required, within 10 working days after the training has completed:
