Specifications

The Driving School is required to provide learner licence, and driver licence training to candidates in line with the National Road Traffic Act, No 93 of 1996.

The Driving School need not be accredited, however, if they are, they are requested to provide proof of: accreditation; scope of training, and roadworthy vehicles/bikes that will be used for training and testing. The Motor Registration Section of Sol Plaatje Municipality will be requested to provide verification of the Driving Schools.

The practical training lessons must take place in Kimberley. The Driving School must include 15 hours of practical lessons for motorcycles, code B, and code C1. The provider must include 20 hours of practical lessons for the code EC.

A roll-out plan is requested for each item quoted for, with timeframes. Lessons may be conducted during working hours (and after working hours) as arranged and agreed with the identified learner and supervisor. The costs of a second attempt must be built into the quote. Learners must be trained and tested in the same vehicle.

The Driving School must meet the deadline dates, failing which the contract will be terminated. A monthly progress report must be submitted with attendance registers.

On completion of all training per line item, the following is required, within 10 working days after the training has been completed:

- the invoice
- issued Drivers Licences (and Professional Driving Permits, in the case of the codes C1 and EC)
- a comprehensive training report
- and attendance register (with times) signed off by each learner.

No additional costs may be charged to learners.

Training will roll out as and when required by the Municipality but all must be completed by 30 June 2024.
