### **Specifications**

The purpose of the study is to determine the viability of closing a section of York Street between Chapel Street and Alan Street, and if viable, what improvements might be required to accommodate the closure.

The proposed methodology will be to determine traffic movements that might be affected and to undertake traffic counts for affected intersections during peak hours. There is a possibility that an extensive number of intersections will have to be counted. Due to this, traffic might have to be distributed based on the observed traffic patterns and the intersections will have to be analysed to determine whether the change in traffic patterns can be accommodated, and if not, what improvements will be required.

The investigation will also indicate the general implications of travel distance.

Bidders will also have to take into account the exit from Shoprite Centre in York Street and the implications of the closure of the exit.

The report should provide information on improvements, and not deal with more detailed designs and cost implications.

Closure of a street usually involves public participation; however, this assessment will not take into account, public participation.

The study should be done as per the requirements of the National Land Transport Act (Act 5 of 2009), according to the procedures prescribed by TMH 16 Volume 1, South African Traffic Impact and Site Traffic Assessment Standards and Requirements Manual.

Please note, as per TMH16, only qualifying Assessors are allowed to prepare a Traffic Impact Assessment.
