In its endeavour to improve drinking water quality management, Sol Plaatje Local Municipality is required to conduct annual process audit of its water supply systems. This will confirm current status, identify gaps and recommend actions to be taken to close gaps.

The municipality owns and operates two water purification works within its jurisdictional area:

- 1. Riverton Water Purification Works (about 162ML/day)
- 2. Ritchie Water Purification Works (about 5ML/day).

The appointed service provider must:

- a. Conduct an annual assessment on water treatment works process, operations and maintenance as per Blue Drop Process Audit Guidelines.
- b. Produce a report of the assessment, with findings and recommendations for process audit improvement.
