

14 DAYS OBJECTIONS AND COMPLAINTS NOTIFICATION

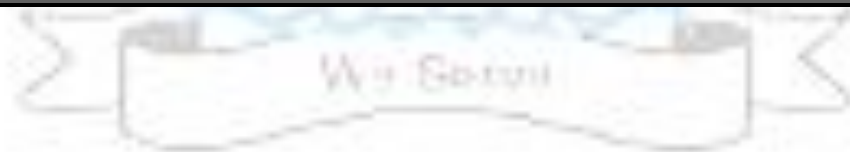
