Buses and taxis can also be impounded for not having a permit or operating contrary to a permit.

According to Act 5/2009 Sec87 (1) an authorised officer who is satisfied that a motor vehicle used by a person for the operation of public transport without the necessary operating license or permit or contrary to the conditions thereof, may impound the vehicle pending the investigation and prosecution of that person for an offence mentioned in section 90(1)(a) or (b).

#### **Special Conditions**
