Technical Specifications

BACKGROUND

A ripple control system was originally installed in Kimberley in around 1962.

It used rotating motor-generator sets to generate the audio-frequency of 725Hz that was injected into the 11kV networks at various 66kV/11kV Municipal substations. The coded control signals were transmitted throughout the distribution network for the control of electro-mechanical receivers which controlled hot water geysers.

Over the years, the system has been modernised, refurbished and extended, all funded by the Municipality. In 2007, in a project 100% funded by ESKOM, all 16 341 electro-mechanical receivers were replaced by solid-state receivers and a new PC-based control system was installed.

In 2012, further extensions and refurbishments including the installation of a new control system were carried out, all funded by the Municipality. However, since then, due to Municipal funding constraints, very limited maintenance has been carried out.

Ripple control injection equipment has failed and needs to be repaired. Break-ins into substation buildings have also occurred, leading to equipment being stolen and damaged.

PROJECT REQUIREMENTS

Implementation of the proposed project would cover two parallel streams:

 Rectify/refurbish/replace faulty injection and control equipment as well as network/communication equipment and cables.

This would include:

- Repair of all communication links between the substations and the Master Controller in the Herlear Substation.
- Repair of the kVA metering system so as to provide indication of total kVA drawn from ESKOM at the H.A. Morris and Herlear Substations.
- o Replacement of numerous faulty modules and displays in the control system.
- Rectification of wiring faults from 11kV/110V VTs to check-back modules.

SRS Transmitter

The SRS (Signal Reference System) transmitter is designed for ripple control applications, offering flexibility and future-proof features. Key specifications include:

Power Range: Available in models ranging from 8 kVA to 400 kVA, catering to various load requirements.

Compatibility: Supports multiple coupling methods such as strong parallel injection, KI-parallel injection, loose parallel injection, 1000 V serial injection, serial injection transformers, and low voltage injection (models SRS-1008 and 1023).

Current Regulation: Features current limitation and regulation functions to ensure stable operation.

Modular Design: Built with user-friendly construction using different functional modules, including transmitter interface, power module, and output unit.

Integrated Communication: Seamlessly integrates with Swistec's RKS controller family (the municipality currently is using Swistec injection equipment), allowing for direct configuration via the RKS-12 local controller. Continuous measurement data is available for real-time monitoring.

RKS Control System

The RKS (Ripple Control System) is designed for managing ripple control tasks efficiently. Notable features include:

Usability and Customization: Based on extensive experience in the ripple control domain, the RKS software offers diverse menus and functions tailored to various tasks. It allows for intuitive operation and easy integration of special customer requirements.

System Configurations: The RKS system is adaptable to different configurations, including centralized systems with a standalone controller and decentralized systems with a central controller managing multiple local controllers. Combinations of these configurations are also possible, providing flexibility to meet specific operational needs.

Monitoring and Operation: Features an "Objects" tab for an overview of the current status of all objects, allowing for easy switching and data display. The "Station" tab provides the status of all connected command devices, enabling monitoring, operation, and updates.

Message Signaling and Archiving: Capable of triggering fault and warning messages from various sources, with customizable signaling behavior for each message type. Messages can be logged, visualized, and acknowledged as needed, with priority-based acoustic signals.

WORK REQUIREMENT

- Repair and service all injection equipment at Southridge and Ashburnham
- Remove old, damaged cards, contactor and Touchscreen at Substation. Install new card, contactor and touchscreen s that will be supplied by the service provider and ensure that all are operational. Clean and rewire all modules to ensure proper and reliable connections.
- Ensure all streetlights are properly switched on and off by the injection equipment according to Municipal requirements.
- Ensure no checkback errors on the injection equipment system.
- Ensure that the injection equipment switches streetlights and geyser ripple relays on and off at the correct times in the evening streetlights switch on and switch off in the morning.
