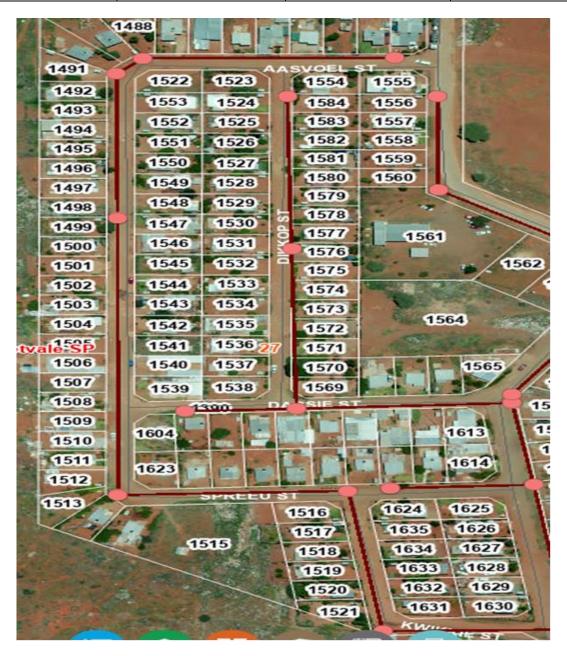
Bidders are required to provide house sewer connections to 21 ERVENS in Rietvale to the bulk sewer system. Number of Ervens in Rietvale have been using the septic tank for the longest period as the only means of sanitation services. With the development that took place in the above-mentioned area most Ervens are now using waterborne sewer network. Only 21 Ervens where not connected.

Service providers or contractors must install house connections from the toilets to the main sewer as identified on the GIS system and with verification onsite.

This will include

- Excavations for laying the house connection pipe (110 mm Ø) PVC
- 100 mm bedding material (Red sand)
- Compaction to the required standard 95% MODASSTO
- 260 mm blanket material (Red Sand)
- Connection to the main bulk sewer line
- Backfilling
