Project Overview

The Sol Plaatje Local Municipality seeks to procure a Steel Container Ablution Facility for installation at the Ritchie Cemetery. The unit will provide adequate sanitation facilities for visitors and workers, ensuring hygiene, accessibility, and compliance with health and safety regulations.

Scope of Work

The appointed service provider will be responsible for the supply, delivery, and installation of a fully equipped steel container ablution facility that meets the following specifications:

1. Container Structure

- 1 x 12m x 2.4m repurposed shipping container (or purpose-built steel structure).
- Fully insulated using Chromadek panels with aluminium flashings.
- Prep, primer, and exterior paint in royal blue finish.

2. Sanitary Facilities

- 5 x Toilets in cubicles:
 - 2 for males, 3 for females (each with doors, privacy partitions, and necessary plumbing).
- 2 x Paraplegic toilets with required fitments, including grab rails.
- 2 x Urinals (for male section).
- 1 x Shower cubicle with 50-litre geyser installed.

3. Fixtures & Fittings

- 4 x Standard hand wash basins with taps.
- 2 x Paraplegic hand wash basins with taps.
- Rubberized non-slip flooring throughout the unit.

4. Doors & Windows

- 2 x Steel entrance doors (one male, one female), each with:
 - Security gates for protection.
 - Wheelchair-accessible ramps for easy access.
- 8 x 600mm x 600mm aluminium windows for ventilation and natural light.

5. Electrical Installations


